The HOD (Civil) and Convener of the Departmental Consultative Committee welcomed all the members. Then the agenda items of the meeting were taken up. The discussions held and the conclusions arrived on various agenda items are given below:

- The HOD (Civil) presented the Vision and Mission statements of the Department. The members of the DCC suggested a few modifications. The modifications were incorporated and the DCC has approved the Vision and Mission Statements.
- The proposal from the Director (IRS) on discontinuance of M.E. (Remote Sensing and Geomatics) on (ii) Self supporting basis from the academic year 2019-2020 onwards has been presented before the Committee. Considering the least employment opportunities for the students and inadequate infrastructural facilities available at the Centre, the proposal has been approved by the IRS faculty and Department Faculty meeting (s).
- The proposal (1) from the Director (CWR) to suspend the intake to B.E. Agricultural and Irrigation (iii) Engineering (Self-Supporting course) from the academic year 2019-2020 onwards due to nonrecognition of the course by AICTE/ICAR and many of the government departments do not have acceptance to the above course.

The Director (CWR) has submitted another proposal (2) to merge the M.E. Integrated Water Resources Management (IWRM), Self Supporting course, with M.E. Irrigation Water Management and M.E. Hydrology and Water Resources Engineering from the forthcoming academic year 2019-2020 as it is very difficult for running this programme in self supporting mode without support from any of the funding agencies. .

The above proposals have been approved by the CWR Faculty and Department Faculty meeting(s).

Keeping the above factors, the Departmental Consultative Committee has recommended the above proposals, i.e. discontinuance of M.E. Remote Sensing and Geomatics (Self Supporting programme), suspend the intake of B.E. Agricultural and Irrigation Engineering Programme, and merging of M.E. IWRM programme with M.E. (IWM) and M.E. (HWRE), for necessary approval from the University. 16/10/18
