


Agenda Item No.2: Extension of start date for III Semester M. Tech., Food Technology in November 2022.




Due to the delayed start of the PG programs in 2022, the students are completing their II semester during September 27th, 2022 and the end semester examinations are scheduled to start from 6th October 2022. As per the current academic schedule of Centre for Academic courses, the re-opening date for the next semester is on 02.11.2022.

Since the 4 week internship is a part of the curriculum for the M.Tech. Food Technology students, the committee recommends, 4 weeks period be given for the internship from the last date of the end semester examination. 
